Article I - Name

The name of the corporation is EMERALD COAST RADIOLOGY, P.A.



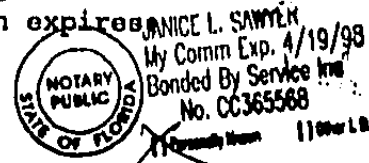

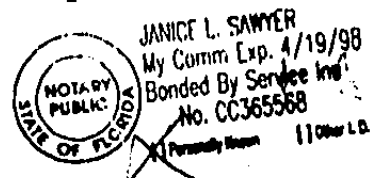
