The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the Corporation (hereinafter called the "Corporation") is Peregrine Ventures, Inc.

SECOND: The street address, wherever located, of the principal office of the Corporation is 7481 SW 50th Terrace, Miami, Florida 33155.

SIXTH: The Corporation may engage or transact in any or all lawful activities or business permitted under any laws of the United States, the State of Florida or any other state, country, territory or nation.

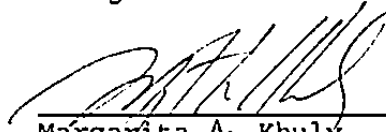
SEVENTH: The duration of the Corporation shall be perpetual.
