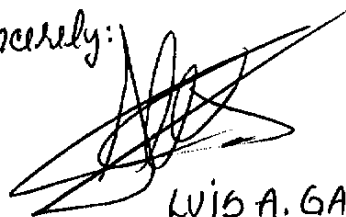
First I would like to thank you for your attention and order for you to understand the situation, I would like to mention, that I have not received the application for the renewal of my company as of today.
