Space Coast Online, Inc. was a new corporation in the year of 1996. The Registered Agent states that he positively did not receive any other form.


I have several clients who formed new corporations in the year of 1996 and everyone of these clients have received a 2nd Notice and definitely state that they did not receive the first notice.
