Articles t

Name, Principal Place of Business, and Duration.

The name of the Corporation is LUIS GONZALEZ P.A. The principal place of business of the Corporation es 1500 S. CONWAY RD., Orlando, Fl. 32812. The duration of he corporation is perpetual.

Articles II

Registered Office and Agent

Articles III

Corporate Purpose, Power and Rights

The general purpose for which this corporation is organized shall be:

- 1. To do anything necessary and proper for the accomplishment or furtherance of any of the purpose or objectives of the Corporation enumerated in these Articles of Incorporation or any amendment, and to do any act necessary or incidental to the protection and benefit of the Corporation; and, in general, either alone or in assocciation with other corporations, films or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purpose or objectives of the Corporation.
- 4. It is intended that this Coporation is organized for and may conduct and transact any or all lawful business authorized and not prohibited by Charpter 607 orr Charpter 621 of the the Florida statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality off the foregoint, this corporation is not to conduct a banking and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition business.
