## ARTICLES OF INCORPORATION OF VINCENZO LOCRICCHIO, P.A.

96 AUG -9 AH 9: 40

The undersigned person, competent and licensed to practice real estate in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, and Section 621, Florida Professional Service Corporation and Limited Liability Company Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME: The name of this Corporation is:

VINCENZO LOCRICCHIO, P.A.

ARTICLE 2: <u>DURATION</u>: The term of existence of the Corporation is perpetual.

ARTICLE 3: <u>PURPOSE</u>: The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of real estate, and all its fields of specializations, as are engaged in by real estate professionals.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be real estate brokers and/or salesmen in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.

- d. To engage in no other business other than the rendition of the professional services specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

## ARTICLE 4: CAPITAL STOCK:

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock at One Dollar (\$1.00) per share par value.
- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- c. Shares of the corporation's stock and certificates shall be issued only to real estate professionals in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.


