ARTICLES OF INCORPORATION

OF

SENIOR PHYSICIAN CORPS, INC.



FIRST: The name of the corporation is "Senior Physician Corps, Inc." (the "Corporation").

SECOND: The Corporation shall have perpetual duration.

THIRD: The Corporation may engage in any act or activity for which a corporation may be formed under the Business Corporation Act, Fla. Stat.
