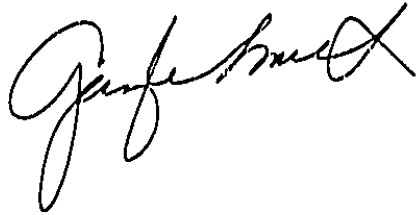

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the state of Florida, adopt the following articles of incorporation:

- FIRST The name of the corporation is The Flooded Swamp Company Inc.
