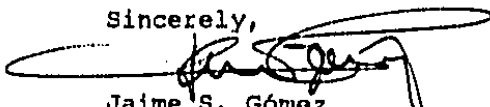
It is true, that all actions or lack of any action taken by this company, although within the laws of the State of Florida and the United States of America, were done without your consultation.

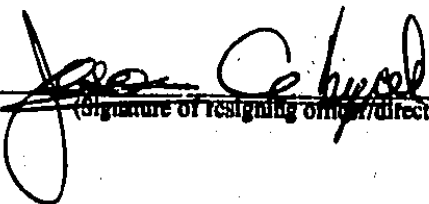
