The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of

ARTICLE I

Name

Inc. Section 1.1. Name. The name of the corporation is Betnan,

ARTICLE II

Duration

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filled by the Department of State of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filling by the Department of State.
