**THE UNDERSIGNED**, acting as sole incorporator of Sign of Jonah, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name and Office**

The name of the corporation shall be Sign of Jonah, Inc., and the corporate address shall be 653 Airmont Ave, Altamonte Springs, FL 32714.

**ARTICLE II**

**Duration**

The duration of the corporation is perpetual.

**ARTICLE III**

**General Purposes**
