OF

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby makes, subscribes and acknowledges these Articles of Incorporation in accordance with the laws of the State of Florida.

ARTICLE I

The name of this corporation is **BLACKBIRD MUSIC, INC.**

ARTICLE II

The nature of the business and the objects and purposes proposed to be transacted by the corporation are:

1. To purchase, sell, rent and otherwise deal, at wholesale or retail, in musical instruments of all kinds, and any and all other kinds of merchandise of any kind or nature.

2. To engage in the business of repairing musical instruments, whether electronic or natural and engaging in any and all activities connected with the operation of the business.

3. To engage in the business of repairing electronic music instruments and other electronic equipment and all other activities connected with the operation of such business.

4. This corporation shall have all the powers, general or specific, specified, granted to or conferred upon corporations for profit under the provisions of Chapter 607, Florida Statutes, and

all of the laws which are amendatory and supplementary to such law. The enumeration of specific powers herein shall in no way limit or restrict this corporation in the exercise of such powers.

ARTICLE III

The maximum number of shares of stock that the corporation is authorized to have outstanding at one time is 25,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV

This corporation is to exist perpetually.

ARTICLE V

ARTICLE VI

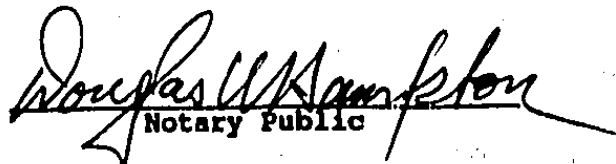
