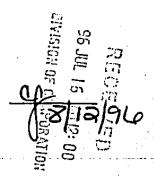

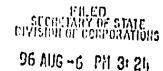

## Articles of Incorporation of InFlorida USA, Inc.



- 1. The name of the organization is inflorida USA, Inc.
