THE UNDERSIGNED, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation Not For Profit for such corporation.

ARTICLE I

The name of the corporation is **FALCON SOUND ALLIANCE, INC.**

ARTICLE II


