#### ARTICLES OF INCORPORATION

of

The undersigned, a natural person competent to contract, acting as incorporator of a corporation under the Fiorida General Corporation Act, Chapter 607, <u>Fia. Stat.</u> (1995), as amended, adopts the following Articles of Incorporation for such Corporation.

Article 1 Name

Article 2
Duration

The duration of this corporation shall be perpetual, commencing on the date these Articles are filed in the office of the Secretary of State of Florida,

Article 3
Purpose

mortgages and flens, without limit as to the amount, upon the property and franchise of the corporation. With the written consent of the holders of a majority of the capital stock issued and outstanding, the directors shall have the authority to dispose of, in any manner, the whole property of this corporation.


