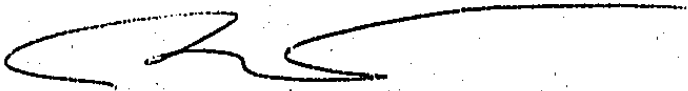

ARTICLE I - NAME

The undersigned natural person, at least 21 years of age for the purpose of forming a corporation, does hereby certify as follows:

FIRST: The name of the corporation shall be and is:
SPORTSMAN'S INFORMATION NETWORK, INC.

SECOND: The general nature of the business to be transacted by the corporation is any business permitted under the Laws of the State of Florida and the United States of America.

THIRD: The amount of common stock with which this corporation shall begin business is FIVE HUNDRED SHARES, each share having a par value of one (\$1.00) Dollar per share.

FOURTH: The corporation shall have perpetual existence.

FIFTH: The principal place of business of this corporation shall be located at 16817 Windsor Park Drive, Lutz, FL 33549.

SIXTH: The business of the corporation and the conduct of its affairs shall be managed by its common shareholders. 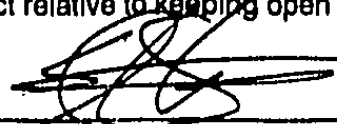
