ARTICLES OF INCORPORATION



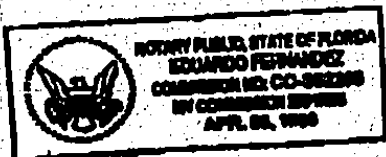
