ARTICLES OF INCORPORATION OF

DEMETRIOS PRODUCTIONS, INC.

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be: DEMETRIOS PRODUCTIONS, INC.
