ARTICLES OF INCORPORATION

OF

I, ALBERT FERRIGNO, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is HUNHIO, INC..

ARTICLE II

This corporation may own and/or operate hair salons, distribute and supply miscellaneous beauty and personal grooming products, and conduct other related enterprises not prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation may issue is Ten Thousand (10,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share. Each shareholder has full preemptive rights to purchase any shares held or owned by other shareholders of the corporation. This corporation will have perpetual existence.
