#### ARTICLE L NAME

The name of this corporation shall be S & F Cabinets, Inc.

# ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles of Incorporation by the SECRETARY OF THE STATE. This corporation's duration shall be perpetual.

### **ARTICLE III. PURPOSE**

This corporation is being organized for the purpose of the construction of commercial and residential cabinetry engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States of America.

#### ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue one hundred (100) common, no par value shares of common capital stock.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.

Each stock certificate issued by this corporation shall carry the following legend:

"These Shares Are Held Subject To Certain Transfer Restrictions Imposed By This Corporation's Articles Of Incorporation, A Copy of Which Is On File At This Corporation's Principal Office."
