The hereby undersigned petition for the formation of a corporation under de laws of the State of Florida, with and under the following Charter:

ARTICLE I

The name of the corporation shall be:

GUSTAVO MOSCOVICH CORP.

ARTICLE II

The general nature of the business to be transacted shall be JEWELRY WHOLESALER and otherwise engage in any activity or business permitted under the laws of the United States of America and this State.

ARTICLE III

The capital stock of this corporation shall consist of 100 shares of common stock of \$1 per value each, all or part of said stock to be issued from time to time as may determine by the Board of Directors.
