**ARTICLES OF INCORPORATION**

The undersigned Incorporators, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of this corporation shall be: VILLAGE INTRODUCTIONS, INC.

**ARTICLE II**

**Principal Office**

The principal place of business of this corporation in the State of Florida, County of Brevard, shall be: Suite 1, 315 Brevard Avenue, Cocoa, Florida 32924.

The mailing address of this corporation shall be: 2515 Suwannee Drive, Cocoa, Florida 32926.

The corporation may from time to time move the principal office to any other address in the State of Florida, and may establish offices at such other places within or outside of the State of Florida as the directors may determine desirable in the furtherance of the purposes of the corporation.

**ARTICLE III**  
Shares

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100. The shares shall be common shares of stock and the shares shall have no par value. The owners of all shares shall be limited to a maximum of 35 owners.

**ARTICLE VI**  
Purposes

The general nature of the business to be transacted by this corporation is to engage or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory, or nation.

This corporation shall have all of the powers given to it by the laws of the State of Florida, now or hereafter, and specific powers herein enumerated shall not be construed as a limitation upon the powers of the corporation.

**ARTICLE VIII**

Directors

This corporation shall have one director initially. The number of directors may increased or decreased from time to time by an amendment of the Bylaws of the corporation in the manner provided by law, but shall never be less than one.

Every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a shareholder's meeting by a majority of the shareholders entitled to vote thereon, unless all of the directors and all of the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
