We never received our Notice for Annual Report nor have we received our Notice of Administration Dissolution or Revocation. We became aware that we did not receive these notifications when we did finally receive Notice of Administrative Dissolution or Revocation on our other business. It was also, the first notification we had received on either business. I spoke with Stacy at your office and she told me what to do and was nice enough to send me an application for reinstatement. We have only had the businesses for about three years and were ignorant to the fact that we must file an annual report when we did not receive notification.

My husband's office is used for the mailing address on each business. We have been having problems with a mail carrier who has been delivering mail since January of this year. Our address had changed slightly to accommodate 911 but we were told that our mail would still be delivered with the former address. We are not the only people that have had trouble with this carrier and it has been documented at the post office. Stacy, at your office, said to fill out the reinstatement form and send the regular fee of \$150.00. She felt that since we had not received prior notification that the penalty fees would be waived. We will be changing our mailing address so that this problem will not occur again.

I'm also, including a copy of the complaint that was filed by Dr. Greene, our neighbor in the same building to show you that it was not only our office that was experiencing mail problems.
