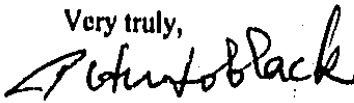

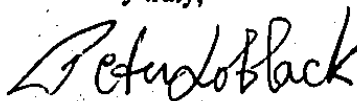

ARTICLES OF INCORPORATION
OF

PLWW COMPANY, INC.

ARTICLE I

The name of the corporation is PLWW COMPANY, INC. (hereinafter called the ("Corporation")).

ARTICLE II

The address of the principal office and the mailing address of the Corporation is c/o: Peter Loblack, Esq., 740 NW 203rd Street, Miami, FL 33169.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

100,000	\$100.00	Non-voting cumulative Preferred

ARTICLE IV

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE V

The street address of the Corporation's initial registered office is 740 NW 203rd Street, Miami, State of Florida 33169, and the name of its initial registered agent at such office is Peter Loblack.

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.

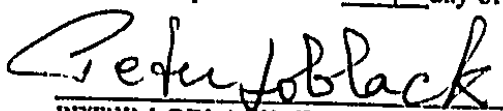
ARTICLE VII

ARTICLE VIII

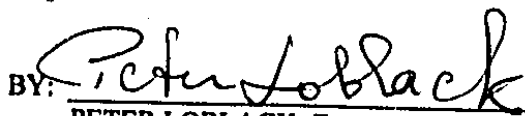
This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
