

# ARTICLES OF INCORPORATION OF EMERALD COAST BANK

FILED 96 NUG 13 NHII145

The undersigned, acting as directors for the purpose of forming a corporation under and LORIOA by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be Emerald Coast Bank and its initial place of business shall be at Beachwalk Center, 7107 W. Highway 98, in the City of Panama City Beach, in the County of Bay and State of Florida.

#### ARTICLE II

The general nature of the business to be transacted by this corporation shall be: That of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

#### ARTICLE III

The total number of shares authorized to 're issued by the corporation shall be 10,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$3,050,000 in paid-in common stock to be divided into 610,000 shares. The amount of surplus with which the corporation will begin business will be not less than \$2,897,500 and the amount of undivided profits not less than \$152,500, all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

Each shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the subscription price offered to the general public, a pro-rate portion of any stock of any class that the corporation may issue or sell.

#### ARTICLE IV

The tram for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

# ARTICLE V

The number of directors shall not be fewer than five (5). A majority of the full board of directors may, at any time during the years following the annual meeting of shareholders in which such action has been authorized, increase the number of directors by not more than two and appoint persons to fill resulting vacancies.
