The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I

The name of the corporation shall be: McCann-Heifin Company

#### ARTICLE II PRINCIPAL OFFICE


