ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF CREATIVE EXCAVATING, INC.

Pursuant to section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

1. The name of the corporation is CREATIVE EXCAVATING, INC.
2. The Following amendment to the Articles of Incorporation (amending Article IV) was adopted by unanimous written consent or vote of the shareholders and directors of the corporation on the 23rd day of December, 1998 in the manner prescribed by the By-Laws of the corporation and the Florida Business Corporation Act:

ARTICLE IV

The number of voting shares which the corporation is authorized to issue is 5,000. The number of non-voting shares which the corporation is authorized to issue is 5,000. All shares shall constitute common stock and shall have the same rights with respect to dissolution and liquidation. All shares shall have a par value of \$1.00 per share.
