ARTICLES OF INCORPORATION

SECHLUSIC OF STATE ALLAHASSEE, FLORIDA The undersigned, acting as an incorporator of a corporation

under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - CORPORATE NAME

The name of the corporation shall be:

SMART ALARM SYSTEMS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III - MATURE OF BUSINESS

The purpose or purposes for which the corporation is organized is for the sale and marketing of alarm system technology to the public in their home or place of business and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the laws of the state, territory, district possession of the United States, or by the foreign country.

ARTICLE IV . AUTHORIZED SMARRS

Number. The aggregate number of shares that the corporation shall have the authority to issue is 500 shares of Capital Stock with a par value of one dollar (\$1.00) per share.

Initial Issue: An initial one hundred (100) shares of Capital Stock of the corporation shall be issued for cash at a value of one dollar (\$1.00) per share.

Stated Capital. The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

Dividends. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

Classes of Stock. The shares of the corporation are not to be divided into classes. There shall be one class known as common shares.

ARTICLE V - PRINCIPAL OFFICE

The principal place of business of said corporation is to be located at: 2201 West Sample Road, Bldg. 9, Suite 3B, Pompano Beach, Florida 33073, and the name of the initial Registered Agent at such address is SUSAN LEVY. The Corporation retains the privilege, however, of having branch offices or places of business at any other place, or places, within or without the State of Florida, or in foreign countries.

ARTICLE VI - CONDUCT OF BUSINESS

The business of this corporation shall be conducted by a Board

of Directors which shall consist of no less than one (1) and no more than three (3) persons, who need not be residents of the State of Florida or shareholders of the corporation.
