ARTICLES OF INCORPORATION

OF

BUILDING BLOCKS LEARNING CENTER OF DESTIN, INC.

ARTICLE I - NAME:

The name of this corporation is: BUILDING BLOCKS LEARNING CENTER OF DESTIN, INC., hereinafter referred to as the ("Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing won the filing of the Articles of Incorporation with the Department.
