**ARTICLES OF INCORPORATION
OF
HERITAGE PARTNERS GROUP VII, INC.**

ARTICLE I - NAME

The name of the corporation is: **HERITAGE PARTNERS GROUP VII, INC.**

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these Articles of Incorporation with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE XVI - RESTRICTIONS OF TRANSFER OF STOCK




