

## ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this corporation is FT. LAUDERDALE DIVING, INC. and its principal place of business is 501 Seabreeze Blvd., Ft. Lauderdale, Florida 33316.

These Articles of Incorporation shall be effective upon filing with the Secretary of State.
