ARTICLES OF INCORPORATION OF
PARADOX ENTERPRISES, INC.

ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: Paradox Enterprises, Inc.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

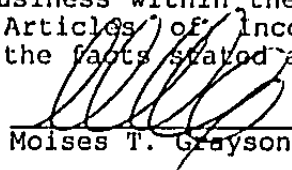
