ARTICLES OF INCORPORATION of Androws Rossi Incorporated

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Andrews Rossi Incorporated.

ARTICLE TWO

The corporation will exist perpetually.
