ARTICLES OF INCORPORATION

OF

GOLDEN EYE ADVERTISING & PRODUCTION COMPANY

The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name and principal address of the corporation is GOLDEN EYE ADVERTISING & PRODUCTION COMPANY, at Suite 492, 1489 West Palmetto Park Road, Boca Raton, FL 33486.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.
