ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

WEST PALM BEACH INTERNATIONAL ART CENTER, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation:

- 1. The name of the Corporation is WEST PALM BEACH INTERNATIONAL ART CENTER, INC.
- 2. Article V of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:

"ARTICLE V CAPITAL STOCK

- (a) The Corporation is authorized to issue One Thousand (1,000) shares of voting Common Stock having a par value of One Dollar (\$1.00) per share.
- (b) The Corporation is also authorized to issue One Hundred (100) shares of Preferred Stock. Preferred Stock shall be non-voting.
- (c) All shares of Preferred Stock shall bear a cumulative dividend of eight percent (8.0%) per annum, based upon the purchase price of said shares at the time of issuance, which dividends shall be paid prior to the payment of any dividends or distributions to the holders of Common Stock. Subject to the provisions of Section 607.0641, Florida Statutes, dividends shall be paid on Preferred Stock on a monthly basis. Any dividends on Preferred Stock not paid on a monthly basis shall be paid as soon as legally permissible under Section 607.0641, Florida Statutes, on a cumulative basis.
- (d) All shares of Preferred Stock shall be redeemable by the Corporation at any time occurring two (2) years subsequent to the issuance thereof, at a redemption price equal to the purchase price of said shares, plus any accrued and unpaid dividends.
- (e) Upon dissolution of the Corporation, the net assets of the Corporation shall be payable to the owners and holders of any outstanding Preferred Stock in an amount necessary to: (i) pay any accrued and

outstanding dividends; and (ii) the redemption price of such Preferred Stock (i.e., repayment of the original purchase price therefore); with the balance of such assets then distributable to the owners and holders of the Common Stock."

3. The Amendment to the Articles of Incorporation was adopted by unanimous written consent of the sole Shareholder of the Corporation dated January 29, 1998, pursuant to the provisions of Section 607.0704, and .1003(6), Florida Statutes.
