ARTICLE I - NAME AND ADDRESS

The name of this corporation is PEMBROKE PINES INSURANCE AGENCY, INC. and the principal address of the corporation is 10031 Pines Boulevard, Suite 222, Pembroke Pines, Florida 33124.

ARTICLE II - PURPOSE

This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE III - CAPITAL STOCK

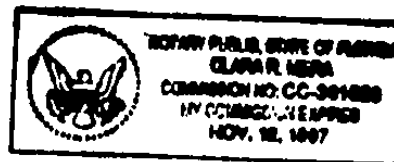


