**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is United Funding Corporation, and the principal address and principal place of business is 1679 Oak Park Drive East, Clearwater, Florida 34624.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 18167 U.S. Highway 19 North, Suite 150, in the City of Clearwater, County of Pinellas, Florida 34624. The name of its registered agent at such address is Patrick M. O'Connor.

**ARTICLE III - PURPOSE**
