ARTICLES OF DISSOLUTION AND COMPANY OF THE LENDING SOURCE CORPORATION

Pursuant to the provisions of section 607.1403, Florida Statutes, this corporation adopts the following articles of dissolution for such corporation:

ARTICLE I. NAME

The name of the corporation is THE LENDING SOURCE CORPORATION

ARTICLE II. DATE OF APPROVAL
