The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is DOLLARS & SENSE ENTERPRISES, INC.

The term of existence of the corporation is perpetual.
