ARTICLES OF DISSOLUTION OF THE COMMERCIAL BANCORP, INC.

The Commercial Bancorp, Inc. (the "Corporation") does hereby set forth the following in connection with the dissolution of the Corporation pursuant to Sections 607.1401, et. al., of the Florida Business Corporation Act:

FIRST: The name of the corporation to be dissolved is The Commercial Bancorp, Inc.

SECOND: The document number of the corporation is P96000067885.
