ARTICLES OF INCORPORATION
OF
ELDORADO RAVENSWOOD LIMITED, INC.

I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit as contained in Chapter 608, Florida Statutes, 1961, and other applicable laws.

ARTICLE I

Name

The name of this Corporation shall be Eldorado Ravenswood Limited, Inc.

ARTICLE II

Address

The initial post office address of the principal office of this Corporation in the State of Florida is: 5201 Ravenswood Road, Suite 103, Ft. Lauderdale, Florida 33312.

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III

Nature of Business

In furtherance and not in limitation of the general powers conferred by the laws of the State of Florida, it is expressly provided that the purposes for which the corporation is to be formed are to do any and all things

hereinafter set forth to the same extent as natural persons might or could do in any part of the world, namely:

- a) To conduct business with the General Public, Private Corporations and entities. To furnish Administrative Management and Consultation Expertise to the same and furnish and manage such personnel as required to conduct Management and Administrative functions. To engage in any form of Commercial enterprise related and unrelated to Consultation and Management.
- b) To acquire by lease, purchase, gift, devise, contract, concession, or otherwise, and to hold, own, develop, control, manage, or otherwise turn to account, mortgage, grant, sell, exchange, convey, or otherwise dispose of, wherever situated, within or without the State of Florida, any and all real estate, lands, options, concessions, grants, land patents, franchises, rights, privileges, easements, tenements, estates, hereditaments, interests and properties of every kind, nature and description whatsoever.
- c) To manufacture, purchase, or otherwise acquire, hold, own, sell, assign, transfer, lease, exchange, invest in, mortgage, pledge, or otherwise encumber or dispose of and generally deal in and trade in and with, both within and without the State of Florida, and in any part of the world, goods, wares, merchandise, property and services of every kind, nature and description.

1. "To enter into, make and perform contracts of every kind and description with any person, firm, association or corporation, municipality, body politic, country, territory, state, government or colony or dependency thereof

ed) To acquire, and to make payment therefore in cash or the stock or bonds of the corporation or by undertaking or assuming the obligations and liabilities of the transferor, or in any part of the assets, tangible or intangible, and to undertake or assume the liabilities of any person, firm, association or corporation, to hold or in any manner dispose of the whole or any part of the property so purchased; to conduct in any lawful manner the whole or any part of the business so acquired and to exercise all of the powers necessary or convenient for the conduct and management thereof.

(f) To adopt, apply for, obtain, register, produce, take, purchase, exchange, lease, hire, acquire, secure, own, hold, use, operate, contract, or negotiate for, take licenses, and rights in respect of, manufacture under, introduce, sell, assign, collect the royalties on, mortgage, pledge, create liens upon, or otherwise dispose of, deal in and turn to account, letters patent, patent rights, patents applied for or to be applied for, trademarks and trade names and symbols, trade dress marks and indicia of ownership, copyrights, syndicate rights, inventions, discoveries,

text, or, machine, improvements, licenses, processes, data and formulas of any and all kind granted by or recognized under or pursuant to the laws of the United States of America, or of any other country or countries whatsoever, and with a view to the working and development of the same, to carry on any business, whether manufacturing or otherwise, which the corporation may think calculated, directly or indirectly, to effectuate these objects.

In GENERAL, to do any or all things herein set forth to the same extent as natural persons might or could do and in any part of the world, as principals, agents, contractors, trustees, or otherwise, within or without the State of Florida, either alone or in company with others, and to carry on any other business in connection therewith, whether manufacturing or otherwise, and to do all things not forbidden, and with all the powers conferred upon corporations by the laws of the State of Florida.

ARTICLE IV

Capital Stock

The total authorized capital stock of this corporation shall be 100 shares of \$1.00 par value common stock.

ARTICLE V

Initial Capital

The amount of capital with which this corporation will commence business is \$100.00.

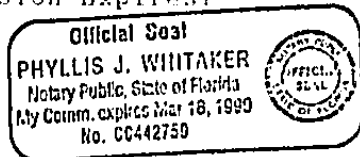
