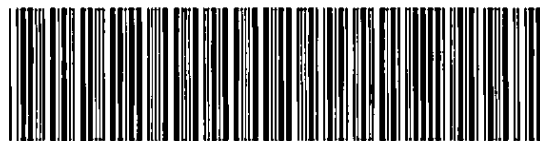

**ARTICLES OF CONVERSION

These Articles of Conversion are submitted to convert Storm Smart Building Systems, Inc., a Florida profit corporation (the "Converting Corporation"), into Storm Smart Building Systems L.L.C. a Delaware limited liability company (the "Surviving Company"), in accordance with Fla. Stat. § 607.11933.

1. The name of the Converting Corporation immediately prior to the conversion is Storm Smart Building Systems, Inc., a Florida profit corporation.

2. The name of the Surviving Company upon the conversion is Storm Smart Building Systems LLC, a Delaware limited liability company.

3. The Surviving Company is a limited liability company formed under the laws of the State of Delaware as of the date of filing of the Certificate of Conversion and Certificate of Formation with the Secretary of State of the State of Delaware. The Certificate of Formation of the Surviving Company filed with the Secretary of State of the State of Delaware is attached hereto as Exhibit 1.

4. The Plan of Conversion for the conversion was approved by the Converting Corporation in accordance with Fla. Stat. §§ 607.11930 through 607.11935.

5. In accordance with Fla. Stat. § 607.11933(4)(b), the conversion shall be effective at the later date of: (a) the date and time provided by the organic law of the Surviving Company; or (b) when these Articles of Conversion take effect.

6. The street and mailing address of the Surviving Company at which the Division of Corporations of the Florida Department of State may send any process served on the Florida Department of State pursuant to Fla. Stat. § 607.0504 and Chapter 48, Florida Statutes, is 6182 Idlewild Street, Fort Myers, Florida 33966.




