ARTICLE I

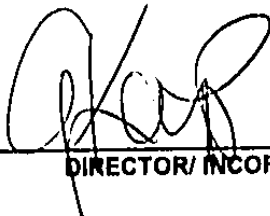

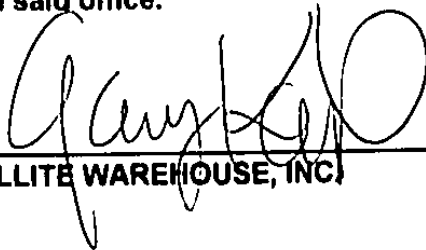
