ARTICLES OF INCORPORATION

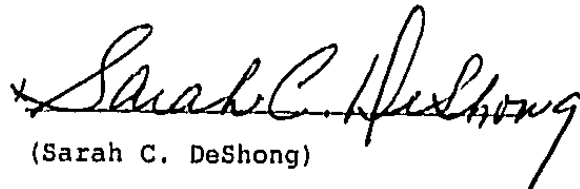
RESTRICTION ON TRANSFER OF STOCK

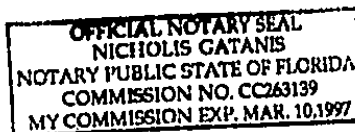
