The undersigned, incorporator, for the purpose of forming a corporation under the Fiorida Business Corporation Act, Chapter 607 of the Fiorida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is ELTEC CONSTRUCTION AND INVESTMENT LTD., INC., hardinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS
