

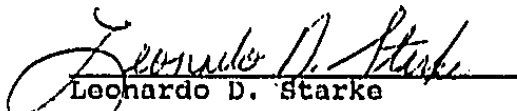

The undersigned, acting as incorporator of a corporation pursuant to the corporate laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

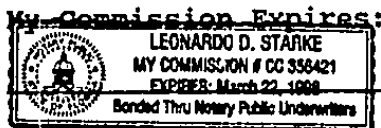
