I.

Name

The name of this corporation is PC Preservation, Inc.

II.

Capital Stock

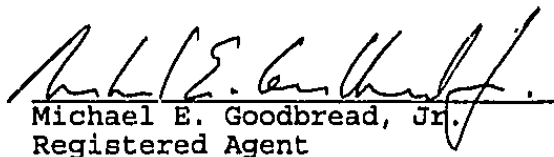
