# ARTICLES OF INCORPORATION OF VINCE'S AUTO BODY & SALES, INC.

We, the undersigned, hereby associate curselves together for the purpose of becoming a corporation under and by virtue of the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

#### ARTICLE I

The name of the corporation shall be:

# VINCE'S AUTO BODY & SALES, INC.

#### ARTICLE\_II

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be as follows:

- 1. To engage in the business of repair and sales of motor vehicles.
  - 2. To engage in all other lawful businesses.
- 3. To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 4. To borrow money of any person, firm or corporation, to issue bonds, debentures, or obligations of this corporation from time to time for any of the object or purposes of the corporation and to secure same by mortgage,

It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

#### ARTICLE IX


