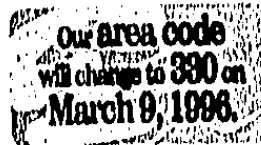

The undersigned incorporator hereby forms a corporation under the Florida Business Corporation Act, by delivering these Articles of Incorporation to the Department of State for filing.

ARTICLE I The name of said corporation shall be JDB SYSTEMS INC.

ARTICLE II This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

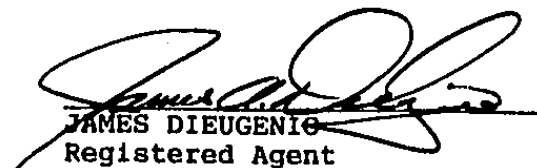
