The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is:
ROSE OF THE SEA, INC.

The principal place of business of this corporation shall be 251 Daytona Avenue, Holly Hill, Florida 32117.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

NATURE OF BUSINESS

This corporation may engage in or transact any of all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 7,500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

AMENDMENT OF ARTICLES OF INCORPORATION

Any amendment to the Articles of Incorporation so made must be approved by a majority vote of the shareholders of the corporation.

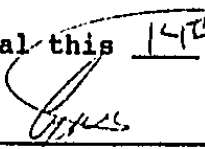

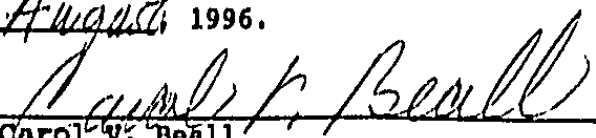
DESIGNATION OF REGISTERED AGENT
